On Monday, April 2, 2018, you will receive an automatic notification from <a href="noreply@njsig.org">noreply@njsig.org</a> letting you know that your application is available. You will receive your user ID and you can reset your password if you do not remember from last year. We will provide you with instructions, however the safety grant application process is faster and more user friendly than ever! The entire application should take no more than a few minutes of your time and you can be on your way to receiving your safety grant.
