Motor Vehicle Accidents are a commonly reported claim. New Jersey Schools Insurance Group offers Defensive Driving Classes. This six hour training was developed by the National Safety Council. Upon successful completion, participants will receive a certificate to be submitted to their insurance carrier, which may entitle them to a 5% reduction in their personal automobile liability insurance premium. In addition, if participants have points against their NJ Drivers license, they may apply to the Department of Motor Vehicles for a possible two-point reduction.

According to the National Safety Council, employers pay significant costs associated with motor vehicle crashes. When employees are involved in traffic incidents, companies are exposed to liability risks and legal expenses, not to mention lost time, decreased productivity and increased insurance and workers' compensation rates.

Implementing a driver safety program, can help your organization keep employees safer and can potentially:

- Decrease risk of motor vehicle collisions and traffic violations
- Minimize exposure to liability risks and legal costs
- Reduce insurance premiums and workers' compensation claims
- Lower vehicle repair bills and replacement expenses
- Protect business operations and brand identity

The "pass the trash" statute, P.L. 2018, c. 5, which went into effect June 1, 2018, requires that all school districts, charter schools, nonpublic schools, and contracted service providers make certain inquiries regarding child abuse and sexual misconduct before hiring any new employee who will have regular contact with students.
