Brennan agreed with this approach. General sentiment was that this approach is workable. Zisa suggested cyber audits as part of the renewal process. LeFebvre and Meloche expressed that distributed talking points on the structure of the program could be very useful, and that they would like to see additional detail on the program structure.
