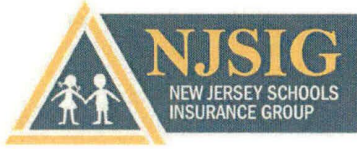
WHEREAS, NJSIG requires professional services in the form of outside counsel to represent the interests of NJSIG and its members;
